Islamic boarding schools, including Dayah Babul Huda, must be able to adapt to changing times and the ever-growing needs of society (Meliani et al., 2022). Research by Meliani et al. shows that Islamic boarding schools must adapt to the typology and dynamics of society to remain relevant and effective in fostering morals and Islamic education (Meliani et al., 2022). Therefore, the religious outreach strategy carried out by religious institutions must be adjusted to the conditions and characteristics of the local community, as expressed by Suryana who emphasized the importance of adjusting the materials and outreach methods based on the conditions of the congregation (Suryana, 2023).

Research by Sabatini shows that empowering youth as drivers in religious activities is very important, but often youth are reluctant to get involved even though they have been trained (Sabatini, 2024). This shows the need for a more inclusive and engaging approach for the younger generation so that they are willing to actively participate in religious activities. In addition, the coaching carried out must focus on strengthening character and morals, which are the key to creating a generation with integrity and able to contribute positively to society (Anwar, 2024).

In facing these challenges, Dayah Babul Huda needs to develop programs that are not only ritualistic in nature, but also prioritize social and educational aspects. The guidance provided must be sustainable and involve various elements of society, including parents and religious leaders, to create an environment conducive to the growth of religious values (Salim, 2023; Setyawati & Mulyo, 2022).
